The grant of rights herein shall include, but are not limited to, the right to adapt or otherwise use the Work, or any portion thereof, alone or in conjunction with other materials in all types of electronic, digital and computer-based media and technologies, now existing or hereafter developed, as well as the storage, retrieval, transmission, display, output, and reproduction of data through any such media and technologies.

Editing and Promotional Rights: Proven Publications shall have the right to edit the Work, provided that the meaning is not materially altered. The Author and/or any Co-Author are hereinafter collectively referred to as the "Author(s)."

Warranty: Author(s) warrant(s) that the Work is original with Author(s); that Author(s) is/are the sole author(s) of the Work; that there is no co-author of the Work except as identified on the front page of this Agreement; that Author(s) is/are the sole holder of the copyright for the Work; that Author(s) has/have the full authority to grant the rights in this Agreement; that publication of the Work will not libel anyone or infringe on or invade the rights of others; that Author(s) has/have full power to enter into this Agreement; and that the Work has not been published elsewhere, in whole or in part, or, alternatively, if the Work has been published previously elsewhere, in whole or in part, Author(s) has obtained written authorization to publish the Work in Proven Publications and shall deliver such authentic record thereof as Proven Publications shall request. Should the Work contain any material that requires written permission for inclusion in the Work, Author(s) agrees to obtain such permission from the copyright owner consistent with this Agreement.

Choice of Law and Venue: This Agreement shall be governed by and construed in accordance with the laws of the Commonwealth of Virginia. Any and all disputes, controversies, lawsuits, or actions arising out of or relating to this Agreement, or the performance or breach thereof, shall be submitted to the exclusive jurisdiction and venue of the courts of the Commonwealth of Virginia, located in Virginia Beach, Virginia. Author irrevocably submits to the jurisdiction of such courts.

Such mailing and/or electronic transmission of a signed copy of this Agreement shall constitute Author's irrevocable and binding execution and delivery of this Agreement.
